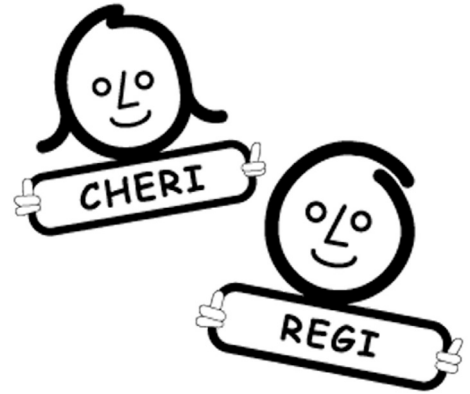

POINTS TO NOTE – PLEASE READ CAREFULLY BEFORE YOU BID

In this brochure are all the details you require to bid in our Sale by Tender of Cherished Registration Marks, which commences on **Thursday 13th October 2011**.

A Sale by Tender means that you submit a bid (on the Tender Form provided) for the lot of your choice. All bids are private; therefore no-one knows what anyone else is bidding. When the sale closes, on **Wednesday 26th October 2011 at 4pm**, the highest bidder gets the lot.

Please note that a minimum bid price of £75 per mark is now required to bid in our Cherished Registration Tender

If you only require one number, only bid for one number. It is not possible to say “if I don’t get this one, I’ll take the other one!”

If your bid is successful you will be informed by way of an invoice in the post. However, you may telephone on **Monday 31st October 2011, after 3pm**.

Finally, please make sure your form is completed and back with us before the closing date (**Wednesday 26th October 2011 at 4.00pm**).

FREQUENTLY ASKED QUESTIONS

ARE YOU BIDDING FROM UK MAINLAND?

Northern Ireland Registration Marks cannot be assigned direct to a vehicle registered in Great Britain. However, you can nominate someone in Northern Ireland to register the number to a vehicle for you first and then transfer it to the Mainland – there may be further transfer costs. We have a list of companies who are members of the Registration Dealers Association (N.I.) who provide this service - list available on request. If you require further details please do not hesitate to contact our office.

NOMINEE

If you are purchasing the number on behalf of someone or as a present, we need to know the name of the person the number is going to be registered to. You must state this name in the section on your Tender Form "NOMINEE". (In the case of purchasing from the mainland we will need the name of the person who is going to register the number for you). If we are not notified and later you need to change the Nominee there will be a charge from the DVA of £25 per plate.

WHAT ARE THE ADDITIONAL COSTS?

On top of the bid price there is VAT payable at the current rate, plus 10% Buyers Premium (a minimum of £25 per plate) plus VAT together with a DVA Assignment Fee of £80. The "READY RECKONER" will assist you in setting a bid limit. (UK MAINLAND BUYERS – further transfer costs may apply, read paragraph "Are you bidding from the UK Mainland").

WHAT TO DO IF MY BID IS SUCCESSFUL

Payment will be taken by the specified method at the top of your Tender Form (Switch/Delta, Major Credit Cards or Cheque) and the invoice forwarded to you by 1st class mail. **If paying by Credit Card there will be a charge of 2.1%.** If you wish to pay by cheque you will need to post your Tender Form with the cheque attached. Please remember that the details you have given on your Tender Form will appear on both your invoice and Certificate of Entitlement.

WHEN WILL I RECEIVE MY CERTIFICATE OF ENTITLEMENT?

A Certificate of Entitlement is prepared by DVA in respect of every Registration Number sold. It authorises DVA Office to assign the Registration Number to a vehicle registered in the name to whom it is issued, or that of the Nominee specified. The Certificate of Entitlement will be released within 21 days of date of payment being received and funds cleared.

ASSIGNMENT PERIOD

The number must be assigned to a vehicle within one year of purchase. If you do not register it before this time you could forfeit the number along with the purchase money. It is possible to apply to DVA for an extension; this currently costs £25 per plate per annum.

2. 3. The highest bidder shall be the Purchaser subject to the Auctioneers having the right to take or refuse any bid and if any dispute shall arise between two or more bidders the Lot so in dispute may be immediately put up again for sale at the last undisputed bidding or the Auctioneer may declare which bidder he thinks proper to be the Purchaser. Every bidder shall be deemed to act as purchaser unless he confirms that he is acting as agent and provides the name and address of his purchaser to the Auctioneers in accordance with condition 7 below.
